Self-Employment Expenses	
<p><i>To accurately calculate your self-employment income, it is important to consider allowable business expenses that can be deducted. Below is a list of common self-employment expenses:</i></p>	
Home Office Expenses: Rent, utilities, insurance, and maintenance costs for the portion of your home used exclusively for business.	
Office Supplies: Paper, pens, printer ink, and other consumable supplies.	
Equipment and Software: Computers, printers, software, and other equipment used for business purposes.	
Travel Expenses: Transportation, lodging, meals, and other costs incurred while traveling for business.	
Vehicle Expenses: Mileage, gas, maintenance, and insurance for a vehicle used for business purposes.	
Advertising and Marketing: Costs for promoting your business, including online ads, print ads, and marketing materials.	
Professional Services: Fees paid to accountants, lawyers, consultants, and other professionals.	
Insurance: Business liability insurance, health insurance, and other relevant policies.	
Rent and Utilities: Costs for renting office space and utilities for business premises.	
Education and Training: Expenses for courses, workshops, and seminars related to your business.	
Licenses and Permits: Fees for business licenses, permits, and regulatory compliance.	
Bank Fees and Interest: Charges for business bank accounts and interest on business loans.	
Employee Wages and Benefits: Salaries, wages, and benefits paid to employees.
